Rick Rackers, an Auxiliary of Assistance League of Long Beach, welcomed 6 law clerk interns from the Long Beach Law Firm of Keesal, Young & Logan to the Philanthropic Center this summer.

These six interns took part in packing backpacks for more than 1600 Head Start children of the Long Beach Unified School District as part of the Operation School Bell program of the Rick Rackers Auxiliary of Long Beach. This is the 2<sup>nd</sup> year that Operation School Bell has provided uniforms and backpacks for the Head Start Program and the first time we had the help of these wonderful interns.

Through the Assistance League of Long Beach Corporate Partnership Program, we received some interest from the law firm of Keesal, Young & Logan (KY&L) who are very prominent in our Long Beach community, seeking an opportunity for this summer's intern program. KY&L recognizes that community service plays a vital role in supporting the Long Beach culture of citizenship, service, and responsibility. Through this partnership program, Operation School Bell provided these 6 clerks with a day of community service stuffing backpacks as well as delivering them to 4 Head Start schools, all in one day. Rick Rackers believes that providing these opportunities for local corporations, such as Keesal, Young & Logan, allows them as well as the volunteers to express their community service while addressing critical community needs. Many corporate programs, such as KY&L's, provide vital assistance to charitable programs such as Operation School Bell, which serves the Long Beach Unified School District. We are so grateful for their support and hope that this experience will encourage other corporations to take part in our corporate partnership program to improve lives, strengthen our community, and foster civic engagement through service and volunteering.

On July 27<sup>th</sup>, Assistance League of Long Beach received a check for \$1000 from the KY&L Summer Associate Class.
